Competitors agree that the sole and inescapable responsibility for the nautical qualities of any yacht participating in the **VOLCANO RACE 2015**, her rigging, the safety equipment on board and the competence, behavior and dress of her crew is that of the Owner/Charterer of the yacht. Competitors also agree to take any and all responsibility for all damages whatsoever caused to third persons or their belongings, to myself or to my belongings, ashore and at sea as a consequence of my participation in the race, and hereby relieve from any responsibility, and agree to indemnify on a full indemnity basis and hold harmless, the Organizing Authority, International Maxi Association (IMA), Yacht Club GAETA, Base Nautica Flavio Gioia SpA, its servants, agents and sponsors and their representatives in respect of any claim arising therefrom. Competitors are to be acquainted with ISAF Part 1 Fundamental Rule 4: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone."

In any case, competitors agree that the Organizing Authority, IMA, Yacht Club Gaeta, Base Nautica Flavio Gioia SpA, its servants, agents and sponsors and their representatives have no responsibility for loss of life or injury to members or others, or for the loss of, or damage to any vessel or property.

As part of the registration process, each individual participating crew member will be required to sign a declaration accepting this disclaimer of liability.

### 2. MEDIA RIGHTS

Competitors and crew members on the competing yachts grant, at no cost, IMA and Yacht Club Gaeta, Base Nautica Flavio Gioia SpA, the absolute right and permission to use their name, voice, image, likeness, biographical material as well as representations of the boats in any media (being television, print and internet media), including video footage, for the sole purposes of advertising, promoting, reporting and disseminating information relating to the **VOLCANO RACE 2015** ("the race"), and to the competitors and crew members' participation in such events.
