NOTICE OF RACE



YACHT CLUB COSTA SMERALDA

Porto Cervo Sunday 5th – Saturday 11th September 2010

The International Maxi Association (IMA) as affiliated Class to the ISAF, has the right to organize the World Championship for the Maxi fleets.

The organization of the first World Championship for the Mini Maxi fleet has been awarded to the Yacht Club Costa Smeralda and will take place in Porto Cervo from September 5th to September 11th 2010, within the Maxi Yacht Rolex Cup.

The official name of the event is Mini Maxi Rolex World Championship, being ROLEX S.A. Geneve, the title sponsor of the event.

1- THE RULES

1.1 The regatta will be governed by the following:

- (a) the *rules* as defined in the Racing Rules of Sailing;
- (b) the ISAF Offshore Special Regulations Category 3 with life rafts compulsorily on board, but subject to the following amendments:
 - i. red parachute flares are not required (amends OSR 4.23)
 - ii. jackstays are not required (amends OSR 4.04)
- (c) The IRC Rules 2010 Parts 1, 2 and 4 shall apply. For the purposes of IRC rules 26.1.5(d) and (e) this regatta is on consecutive days, yet the sails carried on board need not remain the same for the duration of the event but sails need to remain the same for each day;
- (d) IMA Class Rules and Regulations: World Champions title will be assigned to the top scoring boat in compliance with the IMA Rules including the Owner/Driver Rule.
- (e) Notwithstanding anything in the above rules to the contrary, power assisted winches, canting keels, trim tabs and water ballast are permitted as long as each is declared on the IRC certificate.

1.2 No national authority prescriptions will apply except Part 6 of prescriptions of the FIV, which will apply only to Italian nationals. A copy of that prescription is in Appendix A.

1.3 If there is a conflict between languages the English text will take precedence.

2- BOAT ELIGIBILITY

The Championship is open to all maxi boats with an LOA between 18.29 metres and 24.08 metres, of the racing and cruising/racing categories, with a valid endorsed IRC rating certificate (See IRC Rule 8.4).

3- ADVERTISING

- 3.1 Boats may display advertising in accordance with ISAF Regulation 20, Advertising Code. Boats shall display Event Advertising in compliance with ISAF Regulation 20 and as detailed in the Sailing Instructions.
- 3.2 Boats will be required to display the following throughout the period starting one hour after the completion of registration and ending one hour after the finish of the last race of the regatta:
 - a. Sponsor's pennant on the backstay
 - b. Sponsor's decal on each side of the bow
- 3.3 In addition boats will be required to display the event battle flag throughout the same period but only while moored.

- 3.4 The Organizing Authority will supply the pennant, decals and flag at registration.
- 3.5 The Organising Authority may also require the installation, at no cost to competitors, of on board video cameras for the official television production and/or a tracking system.
- 3.6 Boats intending to display advertising during the regatta shall state in the entry form the nature of such advertising.
- 3.7 Boats are responsible to inform advertisers and sponsors that no activities advertising any brand will be permitted ashore within the Porto Cervo Marina Area without the consent in writing of the Organizing Authority obtained before the start of the Regatta.

4- MEASUREMENT AND CONTROLS

- 4.1 All Mini Maxi boats shall be controlled before the event, including weight measurements.
- 4.2 Sail dimensions shall be either by direct measurement performed by an IMA approved IRC measurer or by a certified sail maker declaration

4.3 RATING CERTIFICATES

4.3.1 - IRC certificates may be issued only by the RORC Rating Office: info@rorcrating.com

4.3.2 - All IRC certificates shall be additionally 'endorsed' by the International Maxi Association Technical Office (ATO) who may require full or partial re-measurement of any boat. 5- SAILING INSTRUCTIONS

Sailing Instructions will be available for competitors upon final registration.

6- INTERNATIONAL JURY

Protests will be heard by an International Jury whose ruling shall be final.

The Organising Authority and/or the Race Committee reserves the right to modify the above programme according to weather conditions or other unforeseen reasons.

It is intention of the Race Committee to hold eight windward/leeward races and one coastal race of no more than 150 nautical miles. Scheduled time of first warning signal is 12.00

Four races are required to award the Mini Maxi Rolex World Championship Title.

8- RACING AREA AND CHARTS

The racing area will be in North Eastern Sardinian waters. The following charts are recommended: nos. 42 - 43 - 323 - 324 - 325 - 910, Italian charts of the Istituto Idrografico della Marina. 9- ENTRIES AND ENTRY FEE

9.1 - Entries shall be made on the Entry Form available on the YCCS web site (www.yccs.it) and shall be received, completed in full, by the Yacht Club Costa Smeralda not later than July 1st 2010, accompanied by a non refundable entry fee of 2000 Euro per yacht (the entry fee includes the ISAF charge for the Worlds).

9.2 - Each entry shall also be accompanied by one copy of the current rating certificate. If a boat elects to reconfigure the sail plan or change any other measurement values requiring a new rating certificate, the new certificate shall be received by the O.A., endorsed by the IMA ATO, not later than 1200 hours (noon) on 5th September 2010. Boats intending to update IRC certificates at the last minute shall notify the IMA Technical Office as soon as possible. The ATO will coordinate last minute processing with the Rating Authority office and will be able to advise boats as to when the deadline is for submission of an amended certificate in order to meet the registration deadline at 1200 on 5th September. Since the registration deadline is on Sunday, the deadline may well be several days earlier.

9.3 The Organising Authority reserves the right to accept entries after 1st July 2010.

For late entries moorings are not guaranteed and mooring fees are not included in the entry fee.

9.4 The entry fee can be paid by Credit Card (VISA or MASTERCARD) or by bank transfer. If the payment is made by bank transfer, a copy of the transfer confirmation is to accompany the entry form. Please send the transfer payments to:

10 - REGISTRATION

10.1 Final Registration formalities shall be completed at the Yacht Club Costa Smeralda's Race Office by 12.00 (noon) hours on September 5th, 2010, unless the O.A. agrees to a later date, which it will do only in the most exceptional circumstances

At registration the following documents will be required:

- a. Valid rating certificate unless already produced;
- b. Acceptance of the Notice of Race as set out in the Entry Form;
- c. Disclaimer of liability as set out in the Entry Form
- d. Helmsmen, Relief Helmsmen and Crew list classification. All competitors shall be in compliance with the ISAF eligibility rules and IMA Owner/Driver rule. A representative of the ISAF Sailor Classification Commission will be present during registration and will carry out spot checks.

e. Photography and TV rights consent as set out in the Entry Form.

10.2 Foreign competitors shall be in compliance with their respective National Rules.

11 - SCORING AND PENALTIES

The Low Point System RRS Appendix A shall apply except that one discard will be allowed if five or more races are sailed.

The coastal race cannot be discarded.

12- ELECTRONIC AIDS

All types of electronic equipment are permitted.

13- COMMUNICATIONS

All boats shall be equipped with a Marine VHF transceiver operating on VHF channel 9,16 and 72.

14- INSPECTIONS

Mini Maxi boats competing for the World Championship shall be at the disposal of the Measurement & Inspection Committee not later than 10.00 hours on September 3rd , 2010 except by prior arrangement with the IMA ATO.

15- TROPHIES AND PRIZES

The Mini Maxi Rolex World Championship Trophy and a Rolex watch (timepiece) will be awarded to the top scoring boat in full compliance with the IMA Owner/Driver rule.

An additional Rolex Trophy and timepiece will be awarded to the best classified boat of the Racing/Cruising Category.

An additional trophy will be awarded to the top scoring boat in the Open Category.

16- MOORINGS

16.1 The entry fee includes mooring fees from 08.00 hours on September 3rd to 09.00 hours on September, 12th 2010, at Portisco Marina for the measurement and controls and Porto Cervo Marina provided that the completed entry form and entry fee are received by the Yacht Club Costa Smeralda before 1st July 2010.

16.2 No moorings are guaranteed for late entries and mooring fees are not included.

16.3 The cost of electricity, water consumption and telephone charges as well as mooring fees for late entries and/or additional periods, must be paid directly to the Marina Office by the participants.

18- INSURANCE

It is the responsibility of the owner to provide insurance for the yacht covering damage to persons or property.

19- DISCLAIMER

19.1 Competitors agree to be bound by the International Sailing Federation Racing Rules of Sailing (RRS) 2009/2012, by the Sailing Instructions and the Notice of Race. Competitors agree to take any and all responsibility for the nautical qualities of their boat, the rigging, the crew's ability and the safety equipment. Competitors also agree to take any and all responsibility for damages caused to third persons or their belongings, to themselves or to their belongings, ashore and at sea as a consequence of their participation in the regatta, relieving of any responsibility Rolex S.A., the Yacht Club Costa Smeralda and the International Maxi Association and all persons involved in the organization under whatever qualification and to accept full responsibility for the behaviour and dress of the boat's crew, representatives and guests.

19.2 Competitors are to be acquainted with ISAF RRS Part 1 Fundamental Rule 4: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone".

19.3 In any case, competitors agree that the Yacht Club Costa Smeralda, the International Maxi Association, the sponsors and their agents, have no responsibility for loss of life or injury to members or others, or for the loss or damage to any vessel or property.

19.4 As part of the registration process, each individual participating crew member will be required to sign a declaration accepting this disclaimer of liability.

20- MEDIA RIGHTS

20.1 Competitors grant Rolex S.A. and the Organizing Authority, including the International Maxi Association, the unrestricted right and permission to use the name and the image for any text, photograph or video footage of either themselves or the boat they are sailing during the event to be published or broadcast in any media whatsoever (including but not limited to Press and TV advertisements or Internet), for either editorial or advertising purposes or to be used in press information; in this respect, competitors' names and any biographical material of themselves may also be used or reproduced in any way known.

20.2 As part of the registration process, each individual participating crew member will be required to sign a declaration accepting this waiver of rights.

FIV PRESCRIPTION

PART 6- ENTRY AND QUALIFICATION

Rule 75 - ENTERING A RACE

Prescription to Rule 75.2

The Italian Sailing Federation prescribes: current FIV regulations are to be followed when accepting entries; the competitors must hold a valid and current FIV Membership and the owners of boats of recognized classes, including offshore must also hold a valid and current FIV Membership, even if they are not sailing the race.
